- ❖ WE DO NOT SUBMIT OFFICIAL DOCUMENTS TO DIFFERENT TRANSLATORS IN ORDER TO OBTAIN LOW BIDS BUT RATHER EMPLOY WELL-QUALIFIED TRANSLATORS WHO ARE BEST SUITED TO SPECIFIC CLIENT REQUIREMENTS.
- ❖ WE MUST DECLINE WORK CONSISTING OF TRANSLATION BEGUN OR CONTRIBUTED TO IN ANY WAY BY THE CLIENT OR BY A THIRD-PARTY TRANSLATOR.
